

### Investment Objective

Ethical investing in Australasian equities to achieve above average long-term risk adjusted returns.

The Fund invests directly in Australasian equities, listed property companies and other assets that satisfy Pathfinder's ethical investment criteria. This is a high-conviction fund of top investment ideas and targets a portfolio of 10 to 40 holdings.

### Investing Ethically

1. **UN Sustainable Development Goals:** Aspiring for investment decisions to contribute to UN Sustainable Development Goals.

2. **ESG Incorporation and the UNPRI Framework:** We expect companies that address ESG issues to perform better and be more resilient than companies that don't.

3. **Climate change awareness:** Companies with a lower carbon intensity and a plan for managing the transition to a low carbon economy make better long-term investments.

4. **Aware, Fair, Care:** These are our values as a business and a lens we apply to our share investments.

5. **Active ownership:** Engaging and voting as a shareholder can bring about positive change.

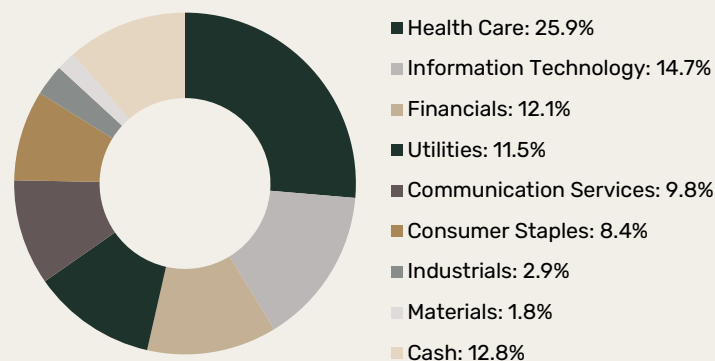
