# **Pathfinder Global Property Fund** Quarter ended 30 September 2021

### What is the purpose of this update?

This document tells you how the **Pathfinder Global Property Fund** has performed and what fees were charged. The document will help you to compare the fund with other funds. Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The fund invests directly in global property stocks that are listed in developed markets. The fund targets a portfolio of 50 to 100 property stocks.

### What are the risks of investing?

Risk indicator for the Pathfinder Global Property Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




## Example of how this applies to an investor

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela made a return after fund charges were deducted of \$2,371 (that is 23.71% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total return after tax of \$2,295 for the year.

The top 10 investments make up 33.95% of the net asset value of the fund.



Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 75% of foreign currency exposures (actual hedging level at 30 September was 82.07%, this will change over time). The unhedged foreign exposure was 14.18% of the Net Asset Value at 30 September 2021 (this will change over time).

#### Notes

- 1) Market Index: We have changed market index for the Global Property Fund from the Morningstar US Real Estate Sector Index to FTSE EPRA/NAREIT Global Real Estate Index in 2020, because the new index has global coverage and is more representative of the Global Property Fund which also invests globally. This is not a material change as the two indexes' returns are broadly similar.
- 2) Accrual Investment Mix: Other refers to unlisted property holdings in this Fund.
