
Description of this fund

The fund invests in global equites that satisfy Pathfinder's socially responsible screening. It achieves this by investing in Pathfinder's wholesale Responsible Investment Fund which targets a portfolio of 200 stocks.

What are the risks of investing?

Risk indicator for the Pathfinder Global Responsibility Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



What fees are investors charged?

Investors in the Pathfinder Global Responsibility Fund are charged fund charges. In the year to 31 March 2022 these were:

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for more information about those fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela incurred a loss after fund charges were deducted of \$975 (that is -9.75% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total loss after charges and tax of \$1,054 for the year.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 50% of foreign currency exposures (actual hedging level at 30 June 2022 was 54.73%, this will change over time). The unhedged foreign currency exposure is 37.91% of the Net Asset Value at 30 June 2022.

Notes

1) Risk indicator: This risk indicator is not a guarantee of a fund's future performance. Market index returns as well as the fund's actual returns have been used to fill in the risk indicator because the risk indicator is calculated using returns data for the five-year period ending on 30 June 2022. Market index returns have therefore been used



for the period from 1 July 2017 to 2 October 2017 when the fund was not in existence, and actual fund returns have been used since then. As a result of those returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.

2) 'Cash at Bank': The fund uses foreign currency cash accounts which can be both positive and negative balances. If all cash positions are netted, the overall cash holding in NZD is 15.11% of the fund net assets.
