
## Description of this fund

The fund invests in global equites that satisfy Pathfinder's socially responsible screening. It achieves this by investing in Pathfinder's wholesale Responsible Investment Fund which targets a portfolio of 200 stocks.

### What are the risks of investing?

Risk indicator for the Pathfinder Global Responsibility Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.



#### Example of how this applies to an investor


Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela received a return after fund charges were deducted of \$2,568 (that is 25.68% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total return after charges and tax of \$2,239 for the year.

The top 10 investments make up 23.35% of the fund.

*Currency hedging:* Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 50% of foreign currency exposures (actual hedging level at 30 September 2021 was 62.17%, this will change over time). The unhedged foreign currency exposure is 33.38% of the Net Asset Value at 30 September 2021.

#### Notes

1) Risk indicator: This risk indicator is not a guarantee of a fund's future performance. Market index returns as well as the fund's actual returns have been used to fill in the risk indicator because the risk indicator is calculated using returns data for the fiveyear period ending on 30 September 2021. Market index returns have therefore been used for the period from 1 October 2016 to 2 October 2017 when the fund was not in existence or available for investors, and actual fund returns have been used since then. As a result of those returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
