#### What is the purpose of this update?

This document tells you how the **Pathfinder Global Responsibility Fund** has performed and what fees were charged. The document will help you to compare the fund with other funds. 
### Description of this fund

The fund invests in global equites that satisfy Pathfinder's socially responsible screening. It achieves this by investing in Pathfinder's wholesale Responsible Investment Fund which targets a portfolio of 200 stocks.

#### What are the risks of investing?

Risk indicator for the Pathfinder Global Responsibility Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

#### What fees are investors charged?

Investors in the Pathfinder Global Responsibility Fund are charged fund charges. In the year to 31 March 2022 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela incurred a loss after fund charges were deducted of \$1,119 (that is -11.19% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total loss after charges and tax of \$1,204 for the year.

Invest Ethically

*Currency hedging:* Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 50% of foreign currency exposures (actual hedging level at 30 September 2022 was 52.17%, this will change over time). The unhedged foreign currency exposure is 41.94% of the Net Asset Value of the Fund at 30 September 2022.
