## **Pathfinder Global Water Fund**

#### What is the purpose of this update?

This document tells you how the **Pathfinder Global Water Fund** has performed and what fees were charged. The document will help you to compare the fund with other funds. Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The fund invests directly in companies involved in the water industry that satisfy Pathfinder's socially responsible investment screening. The fund targets a portfolio of 50 to 100 water stocks that are listed in developed markets.

#### What are the risks of investing?

Risk indicator for the Pathfinder Global Water Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



#### Annual return graph





This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2019.

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela received a return after fund charges were deducted of \$3,260 (that is 32.60% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a return after tax of \$3,138 for the year.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The currency hedging level implemented in the fund at the quarter end was 33% (this will change over time).
