
Description of this fund

The fund invests directly in companies involved in the water industry that satisfy Pathfinder's ethical investment criteria. The fund targets a portfolio of 50 to 100 water companies.

What are the risks of investing?

Risk indicator for the Pathfinder Global Water Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



What fees are investors charged?

Example of how this applies to an investor


Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela incurred a loss after fund charges were deducted of \$1,624 (that is -16.24% of her initial 10,000). Angela did not pay any other charges. This gives Angela a total loss after tax of \$1,695 for the year.

The top 10 investments make up 43.44% of the fund.



Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 50%, and actual hedging level is 53.35% at 31 December 2022 (this will change over time). The unhedged foreign currency exposure is 40.34% of the Net Asset Value of the Fund at 31 December 2022.
