
Description of this fund

The Fund invests directly in Australasian equities, listed property companies and other assets that satisfy Pathfinder's ethical investment criteria. This is a high-conviction fund of top investment ideas and targets a portfolio of 10 to 40 holdings.

What are the risks of investing?

Risk indicator for the Pathfinder Ethical Trans-Tasman Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




Example of how this applies to an investor

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela incurred a loss after fund charges were deducted of \$1,344 (that is -13.44% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total loss after charges and tax of \$1,371 for the year.

The top 10 investments make up 58.08% of the net asset value of the fund.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level



implemented in the fund is 50% (actual hedging level is 52.32% at 31 December 2022, this will change over time). The unhedged foreign currency exposure is 22.92% of the Net Asset Value of the Fund at 31 December 2022.
