## What is the purpose of this update?

This document tells you how the Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# What are the risks of investing?

Risk indicator for the Pathfinder Ethical Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

# How has the fund performed?



The market index annual return is the Morningstar® Target Allocation Index™: Growth Multisector for New Zealand, 100% non-New Zealand Fixed Interest in the Fund hedged to NZD, 0% other non-New Zealand assets hedged to NZD. The index is gross of dividends and tax except for International Equities and International Listed Properties, which are gross of dividends after deducting the tax withheld.

The market index changed on 1 October 2021. The previous index was a weighted composite benchmark index as described in the SIPO ("3. Investment objective and benchmark") dated 28 December 2022. The new index is independently administered and widely used to compare funds in New Zealand. The manager also considers that the new market index is more appropriate for measuring changes in the market in relation to returns on the assets that the Fund invests in. As a result of this change, the market index annual return is calculated using the previous market index for the period from 17 August 2020 to 30 September 2021 and the new market index from 1 October 2021.

#### Annual Return Graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2023.

# What fees are investors charged?

Investors in the Pathfinder Ethical Growth Fund are charged fund charges. In the year to 31 March 2022 these were:

Other management and administration charges comprise fees paid by the Fund in the year to 31 March 2022 for its investment in the Alvarium Private Credit Fund, a related fund, which the Fund no longer holds.

Performance fees and individual action fees: There are no performance fees or individual action fees.

The fund does not charge any registration fees or individual action fees. See the <u>PDS</u> for more information about those fees.

Example of how this applies to an investor




Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela incurred a loss after fund charges were deducted of \$270 (that is -2.70% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total loss after charges and tax of \$273 for the year.


This shows the type of assets that the fund invests in.

The total value of the top 10 investments make up 25.02% of the net asset value of the fund. Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging is 0% of non-NZD equity exposure and 100% of non-NZD fixed interest exposure (actual hedging level was 53.89% at 31 March 2023 (this will change over time)). Total unhedged foreign currency exposure is 30.97% of the net asset value of the fund at 31 March 2023 (this will change over time).

#### Notes:

1. Risk Indicator: This risk indicator is not a guarantee of a fund's future performance. Market index returns as well as the fund's actual returns have been used to fill in the risk indicator because the risk indicator is calculated using returns data for the five-year period ending on 31 March 2023. Market index returns have therefore been used for the period from 1 April 2018 to August 2020 when the fund was not in existence, and actual fund returns have been used since then. As a result of those returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates. As more of the fund's actual returns are used to calculate the risk indicator over time, the effect of the change in market index on the risk indicator will decrease. However, as already noted, any use of market index returns may result in a less reliable indicator of potential future volatility of the fund.

2. Actual Investment Mix - Other: Other assets are direct investments that are unlikely to be stock exchange listed. These can include investments known as 'impact investments', 'venture capital', 'private equity', carbon credits, and also 'private credit'. This category also includes unlisted property, such as direct ownership in property or ownership of property companies that are not listed on a stock exchange.
