Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.


Description of this fund

The Fund invests directly in listed property companies that satisfy Pathfinder’s ethical investment criteria. The Fund targets a portfolio of 50 to 100 property companies.

What are the risks of investing?

Risk indicator for the Pathfinder Global Property Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Annual Return Graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2025.

What fees are investors charged?

Example of how this applies to an investor


Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela received a return after fund charges were deducted of \$266 (that is 2.66% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total return after tax of \$167 for the year.



What does the fund invest in?


This shows the type of assets that the fund invests in.

The top 10 investments make up 31.66% of the net asset value of the fund.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 75% of foreign currency exposures (actual hedging level at 31 March 2025 was 74.67%, this will change over time). The unhedged foreign exposure was 22.06% of the Net Asset Value of the fund at 31 March 2025 (this will change over time).

Notes:

1. Market Index: We have changed the market index for the Global Property Fund from the Morningstar US Real Estate Sector Index to FTSE EPRA/NAREIT Global Real Estate Index in 2020, because the new index has global coverage and is more representative of the Global Property Fund which also invests globally. This is not a material change as the two indexes' returns are broadly similar.
