#### What is the purpose of this update?

This document tells you how the **Pathfinder Global Water Fund** has performed and what fees were charged. The document will help you to compare the fund with other funds. Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this Fund

The Fund invests in listed water companies. Water companies cover a wide range of activies, including water utilities, filtration, monitoring technology and the manufacture of pumps, pipes and irrigation equipment.

#### What are the risks of investing?


### How has the fund performed?


### Example of how this applies to an investor

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela received a return after fund charges were deducted of \$222 (that is 2.22% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total return after tax of \$139 for the year.

The top 10 investments make up 39.59% of the net asset value of the fund.

**Currency hedging**: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 50%, and actual hedging level is 51.14% at 31 March 2023 (this will change over time). The unhedged foreign currency exposure is 44.06% of the Net Asset Value of the Fund at 31 March 2023.
