This fund update was first made publicly available on 13 February 2025.

#### What is the purpose of this update?

This document tells you how the **Pathfinder Global Water Fund** has performed and what fees were charged. The document will help you to compare the fund with other funds. Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this Fund

The Fund invests directly in companies connected to water quality, accessibility or sustainability that satisfy Pathfinder's ethical investment criteria<sup>1</sup>. The Fund targets a portfolio of 50 to 100 water companies.

### What are the risks of investing?

Risk indicator for the Pathfinder Global Water Fund:





The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# Example of how this applies to an investor


Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela received a return after fund charges were deducted of \$937 (that is 9.37% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total return after tax of \$837 for the year.



#### What does the fund invest in?


This shows the type of assets that the fund invests in.

The top 10 investments make up 44.97% of the net asset value of the fund.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 50%, and actual hedging level is 53.57% at 31 December 2024 (this will change over time). The unhedged foreign currency exposure is 46.08% of the Net Asset Value of the Fund at 31 December 2024 (this will change over time).
