What is the purpose of this update?

This document tells you how the **Pathfinder Green Bond Fund** has performed and what fees were charged. The document will help you to compare the fund with other funds. Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

The Fund invests in fixed income securities that are classified as "Green Bonds". The Fund's investments are managed by MetLife Investment Management.

What are the risks of investing?

Risk indicator for the Pathfinder Green Bond Fund:





The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?



Performance fees and individual action fees: There are no performance fees or individual action fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela received a return after fund charges were deducted of \$445 (that is 4.45% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total return after tax of \$319 for the year.



What does the fund invest in?


This shows the type of assets that the fund invests in.

The top 10 investments make up 33.48% of the net asset value of the fund.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 100% of foreign currency exposures (actual hedging level at 30 June 2025 was 98.88%, this will change over time). The unhedged foreign exposure was 1.03% of the Net Asset Value of the fund at 30 June 2025 (this will change over time).

Notes:

1. Risk indicator: The risk indicator is not a guarantee of a fund's future performance. Market index returns as well as the fund's actual returns have been used to fill in the risk indicator because the risk indicator is calculated using returns data for the five-year period ending on 30 June 2025. Market index returns have therefore been used for the period from 1 July 2020 to 27 January 2023 when the fund was not in existence, and actual fund returns have been used since then.
